Demand that your State Legislators DO NOT attend The Regional Government, National Conference of State Legislators on July 23 to 27 in San Francisco, California.

This Conference is a Regional Government THINK TANK. It is funded in part by Regional Government Agencies including the Regional Agency LEAA (Law Enforcement Assistance Administration). The Agency that calls for:

#### GUN CONFISCATION

The intentions of a Foundation that is funding this Conference should certainly serve as a Red Flag. Note Below:

This National Conference of State Legislatures, Education Project, is funded by a Grant from the Ford Foundation.

Congressional Records show:

Mr. Norman Dodd was Director of Research during the House Committee Investigation of Tax Exempt Foundations (including the Ford Foundation).

During the Investigation, Mr. Gaither, President of the Ford Foundation, stated to Mr. Dodd in effect:

"We ( The Ford Foundation) operate and control our Grant Making Policies, to alter life in The United States, so that it can comfortably, be merged with the Soviet Union."

These Ford Foundation Policies are frightening. Should this Foundation be funding the State Legislatures Conference?

Chapter 36 of this Kennedy Bill, No. 1437, has lock up provisions that would allow for any person to be locked up for life without a trial.

Even though the person is totally innocent of any charge, they could force him to receive shock treatments and deadly psychiatric drugs.

We are following two such cases at this time.

The Federal Regional Agency L.E.E.A. (Law Enforcement Assistance Administration) along with HEW and it's INstitute of Mental Health have been proven to have been involved in such atrocious acts.

This Bill No. 1437 was written as a John Mitchell Bill and is even now being pushed by the Justice Department, of which LEAA is a Powerful Arm.

Don't think for one moment that this can't happen!

We are already well on our way.

Our Indiana State Legislature passed a Bill allowing for the tampering with the brain even before this confined person is proven guilty of any offense.

**Freedom, will soon be only a memory in the United States. How could this happen, in this great Land?**

After the two horrible World Wars, another 95,000 more men died for their country, and many, many thousands were wounded. What a tragedy, that after this great loss of lives, and after all the suffering of these men and their families, that the citizens of this Nation, are allowing their country to be taken over from within.

Our country is bankrupt, our Freedom is nearly gone, and we have but ourselves to blame. Although time is short, there is a way to regain the freedom that we have lost. There is a way, if the people of this Nation care enough to act.

Our United States Congress, must take back the power that they have relinquished. Remember, that was our power, because Congress is lawfully our servant. They must then abide by the Constitution. For the Constitution is the Law. We can and must, regain the sovereignty of every single State.

This can be done by having Bills passed in every State Legislature to outlaw Regional Government. It can be done. Nearly twenty States are in the process of proving it.

We must not fail our children, we must not fail our country. and we must not fail those who gave so much for our Freedom.

# Community Correction Centers

Dangerous laws pertaining to Community Correction Centers have been passed by the Indiana State Legislature. These laws allow for the detention, treatment, diagnosis and rehabilitation of offenders; Before or after conviction. These acts could be highly detrimental. Who decides the treatment? Then imagine if the person is innocent. Treatment could be a disaster.

Check and see if these same laws have been passed in your state without your knowledge. Hard to believe, but many Indiana Legislators did not even know they passed a Bill with these frightening aspects.

## 11-1-5-2 Purpose of centers

Sec. 2. Community correctional centers may be used for detention, treatment, diagnosis and rehabilitation of adult and juvenile offenders either before or after conviction and adjudication of any offense.

T. David Horton - Legal Counsel for the National Committee To Restore The Constitution, called attention to the fact that as long as we retain our own County Jails and County Sheriffs, we are far more secure. Federally Funded and Controlled Correction Centers could become a nightmare and we know our rights could easily be ignored.

Senator Kennedy's Senate Bill No. 1437 certainly proves that T. David Horton was correct. This Bill, although it has not yet passed the House, has passed our United States Senate by a wide margin of 75 to 14.

Following are parts of this nightmare bill.

### § " 574. Federal Institutions in a State Without an Appropriate Facility"

"If there is not a valid contract with a state or locality for the official detention of a federal offender, and if there is no suitable and sufficient facility available at reasonable cost, the Director of the Bureau of Prisons may select a site within or convenient to such state or locality and erect a penal or correctional facility. Such facility may be used for the official detention of persons held under the authority of title 18 or of any other Act of Congress and of any other person who in the opinion of the Director, is a proper subject for official detention in such facility.

This last sentence spells the end of your Freedom. It would give the Director total power over your life. He would have the power of the KGB or the Gestapo. No day of your life could ever really be free again. Remember: This bill has passed our United States Senate by a wide margin.

Note: The Director would have unlimited power in this Correction Center, and the Correction facility will also be under the supervision of an Advisory Board, which includes The Administrator of LEAA-Law Enforcement Assistance Administration and HEW with its subagency, The National Institute of Mental Health.

### § " 576. National Institute of Corrections

"(a) There is hereby established within the Bureau of Prisons a National Institute of Corrections.

"(b) The overall policy and operations of the National Institute of Corrections shall consist of seventeen members. The following seven individuals shall serve as members of the Institute ex officio: the Chairman of the United States Sentencing Commission or his designee, the Director of the Bureau of Prisons or his designee,, the Director of the Federal Judicial Center of his designee, the Chairman of the United States Parole Commission or his designee, the Administrator of the Law Enforcement Assistance Administration for the National Institute for Juvenile Justice and Delinquency Prevention or his designee, and the Assistant Secretary for Human Development of the Department of Health, Education, and Welfare or his designee.

This meeting was sponsored by the Indiana Lawyers Commission, The Criminal Justice Section of the American Bar Association and the Criminal Justice Program of the Aspen Institute of Humanistic Studies.

The Philosophy of the Aspen Institute is: Forget the United States as a Nation that is sovereign. They also encourage youth to work toward World Government. They promote the Humanistic teachings that state: THERE IS NO GOD.

**200 Expected At Meeting To Explore Crime Causes**

Nearly 200 persons are expected to attend a four-day meeting, beginning Wednesday in the Indianapolis Hilton, to study crime links with unemployment, brain dysfunctions, prison terms, diversion from prison, probation and parole.

**Police chiefs kick out Murphy**

Former New York City Police Chief Patrick V. Murphy, who earned a nationwide reputation for his anti-gun feelings, was drummed out of the New York State Association of Police in August for "demonstrating disrespect for the police profession." Delegates to the annual Conference of Chiefs in Syracuse voted to remove Murphy's name from the membership rolls.

Lake Success, N.Y., Police Chief Walter F. Ruckgaber, who introduced the resolution to remove Murphy's name, attributed the following remarks to Murphy: "Police who work their way up through the ranks generally don't make good chiefs. . . . Small town chiefs are weak-kneed, ineffectual and unintelligent. . . . Generally, small departments are policed by a farcical collection of untrained individuals who are little more than security guards."

**SEPT. 20-23 'COLLOQUIUM' - WEDNESDAY, SEPTEMBER 6, 1978**

**Experts To Gather Here, Discuss Crime**

Some of the nation's top criminal-justice professionals will be in Indianapolis Sept. 20-23 to discuss better ways to attack crime.

The national "Criminality Colloquium" will meet at the Hilton Hotel and include judges, criminologists, prosecutors, law professors, psychologists and correction commissioners.

The summit meeting is sponsored by the Indiana Lawyers Commission, the Criminal Justice Section of the American Bar Association and the Criminal Justice Program of the Aspen Institute for Humanistic Studies.

Patrick V. Murphy of Washington, director of the Police Foundation, and Frank J. Remington, University of Wisconsin Law School professor, will discuss the role of police in the criminal-justice system.

Using a "living stage" approach, the colloquium also will have a six-member cast act out three violent crimes, with the authorities discussing the causes and

what society's response should be. The discussions will cover the social and economic factors leading to crime; deterrence and prevention, trial procedures and the functions of punishment, rehabilitation and community-based corrections.

Judge David L. Bazelon of the U.S. Court of Appeals for the District of Columbia will address the authorities during a dinner meeting Sept. 21 on "What Should be Criminal?"

# INDIANA LEGISLATORS PASS MENTAL HEALTH PROGRAMS PROMOTED AND DIRECTED BY FEDERAL GOVERNMENT

One of the largest supporters of "behavior research" was the Department of Health, Education and Welfare, and its subagency the National Institute of Mental Health. The subcommittee said that HEW had participated in a "very large number of projects dealing with the control and alteration of human behavior." Largest of all the supporters of behavior modification was the Law Enforcement Assistance Administration (LEAA) which, under the Department of Justice, funded hundreds of behavior modification experiments. All the above agencies were named in secret CIA documents. - Facts taken from reference book: "Mind Control".

Indiana fell into the trap of cooperating with these sinister agencies: The LEAA and HEW's sub agency National Institute of Mental Health.

With the blessing of the Indiana Legislature, appropriations for mental health clinics were approved to meet Federal guidelines on Mental Health.

The plans for 32 Regional Mental Health Clinics in Indiana were pushed ahead by Mr. Percy Knauth, National Chairman of the Mental Health Association. Mr. Knauth, himself, was diagnosed as a manic-depressive in 1971. Every Legislator in Indiana received a copy of the "Little Report", titled, (Will Indiana choose New Directions in Mental Health?) The plan outlined in the "Little Report" was to have schools near the Mental Health Clinics. Children are to be trained in giant pilot school projects. (Designed not by educators but by "Behavior Scientists" - (Change Agents.)

The Hawaii Master Plan for Education (the Master Plan actually for the whole nation) states: Schools of the future will become Mental Health Clinics. Teachers will be clinicians or facilitators and the children will be looked upon as Patients.

In 1956 THE ALASKA MENTAL HEALTH ACT known as H.R. 6376 was passed and is law.

The mental health bills passed in our Indiana General Assembly violate the basic tenets set forth in the Constitution.

The "Brooklyn Tablet" for March 31, 1956, states in part: "The bill passed by the States' Legislatures, like H. R. 6376, makes it possible for the Administration in power to have a political nuisance transported to the 1,000,000 acre, ALASKA MENTAL INSANE ASYLUM."

The World Federation for Mental Health reveals in its literature what the aims and objectives are.

"in the event non-conformists should refuse to become part of the 'STABLE AND CONTENTED' society and become a 'NUISANCE TO THE COMMUNITY' and the powers that be, it will be simple legally, to REMOVE THEM FROM CIRCULATION."

Senate Bill 1437 with its parts on Correction Facilities would certainly fit perfectly with these objectives. Parts of this bill's nightmare plans are on page 12 and 13 of this pamphlet.

# LEAA FUNDS COMMUNIST FRONT ORGANIZATION

The Regional Agency, LEAA (Law Enforcement Assistance Administration) was exposed before a United States Internal Security Subcommittee Hearing for the funding of a Communist Front Organization. 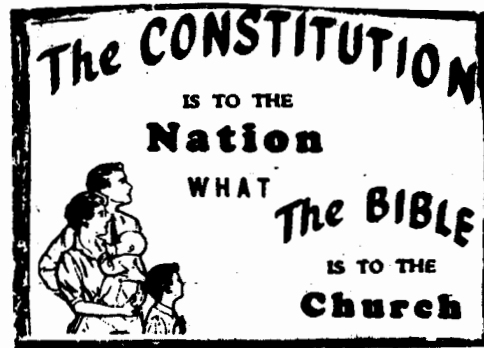

# ***Revenue Sharing Money Brings Federal Control***

Regional Government Republicans will even go so far as to insist that on certain projects the Federal Government will not interfere in any way, when we accept Revenue Sharing Money, Federal Grant Money and Federal Title Money.

School Officials who accepted Regional Government Agency LEAA Money have also insisted that there would be no control whatsoever and that LEAA only wanted to help fund needed counselors in the school.

The Supreme Court spelled it out very clearly as to federal money meaning Federal Control.

In the case of Wickard vs. Filburn: The Supreme Court ruled in 1942 that the Federal Government has the right to regulate that which it subsidizes.

Revenue Sharing Money is a subsidy. And it is absolute Debt Money. Revenue Sharing Money is not our share of the money we send to Washington. That money is spent before it gets there. Revenue Sharing Money finances Regional Government. Regional Government is a totally separate government made up of appointed officials. The appointed officials are now controlling our elected officials. Regional Government, through its nine Federal Regional Grant making Agencies, (see page 4) is filtering Revenue Sharing Funds, Grant Making Funds, and Title Money into every facet of our lives. And with the money comes the regulations. We the citizens of the United States are liable for all this debt money plus the interest that is mounting daily. Regional Government is working toward the elimination of the elected officials. In numerous States the offices of many elected officials have already been eliminated.

Robert Weaver, former Secretary of HUD (Housing and Urban Development) said: "Regional Government means absolute Federal Control over all property and its development regardless of location anywhere in the United States . . . It would supersede state and local laws."

Lt. Governor John Vanderhoof of Colorado, declared, and I quote: "By 1980, the individual citizen will have very little to say about the use of his own property." He further stated that County Commissioners would soon be a thing of the past.

All of this control is to aide in taking the United States into the World Government Order. Since the beginning of time, a certain group of men have desired to rule all others. In the eighteen hundreds it was well planned. Over seventy years ago the program was set in real motion by a group of men who intended to rule the whole world. The United States was to be the grand prize. Many of the men in this group were wealthy United States citizens, but their only interest in the United States was to own and control it under their World Government Plan. The group as a whole were men from various parts of the world. They were members of International Banking or International Business Conglomerates or both. They set up, Organizations, Committees, Conferences, Systems and Tax Free Foundations, which they used to further their World Government Plan. One such organizational meeting they held, was the Bilderberger Meetings. Here the top leaders met once, and at times, twice a year, since the early fifties. At these meetings they made yearly plans for furthering the World Government Scheme.

The CED, CFR, NEA and all those listed on page seven are part of the World Government Plan. Volume II will give the total World Government Network, with the United Nations being planned for the World Government Police Force.

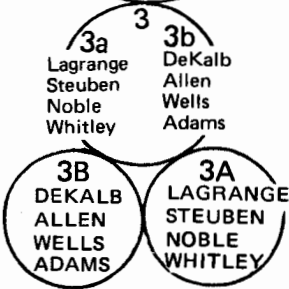

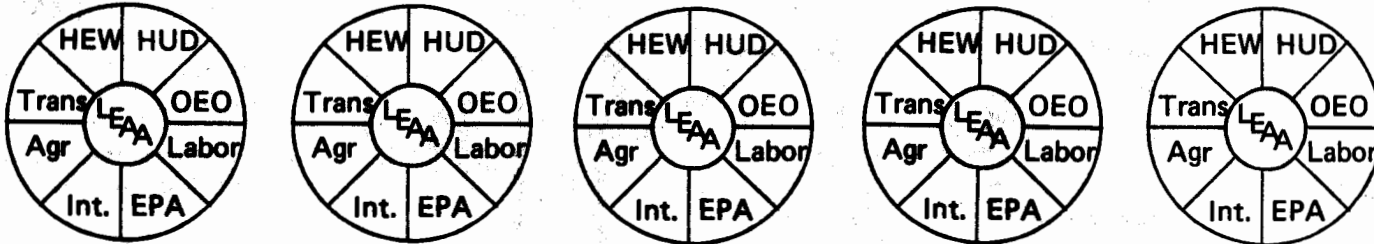

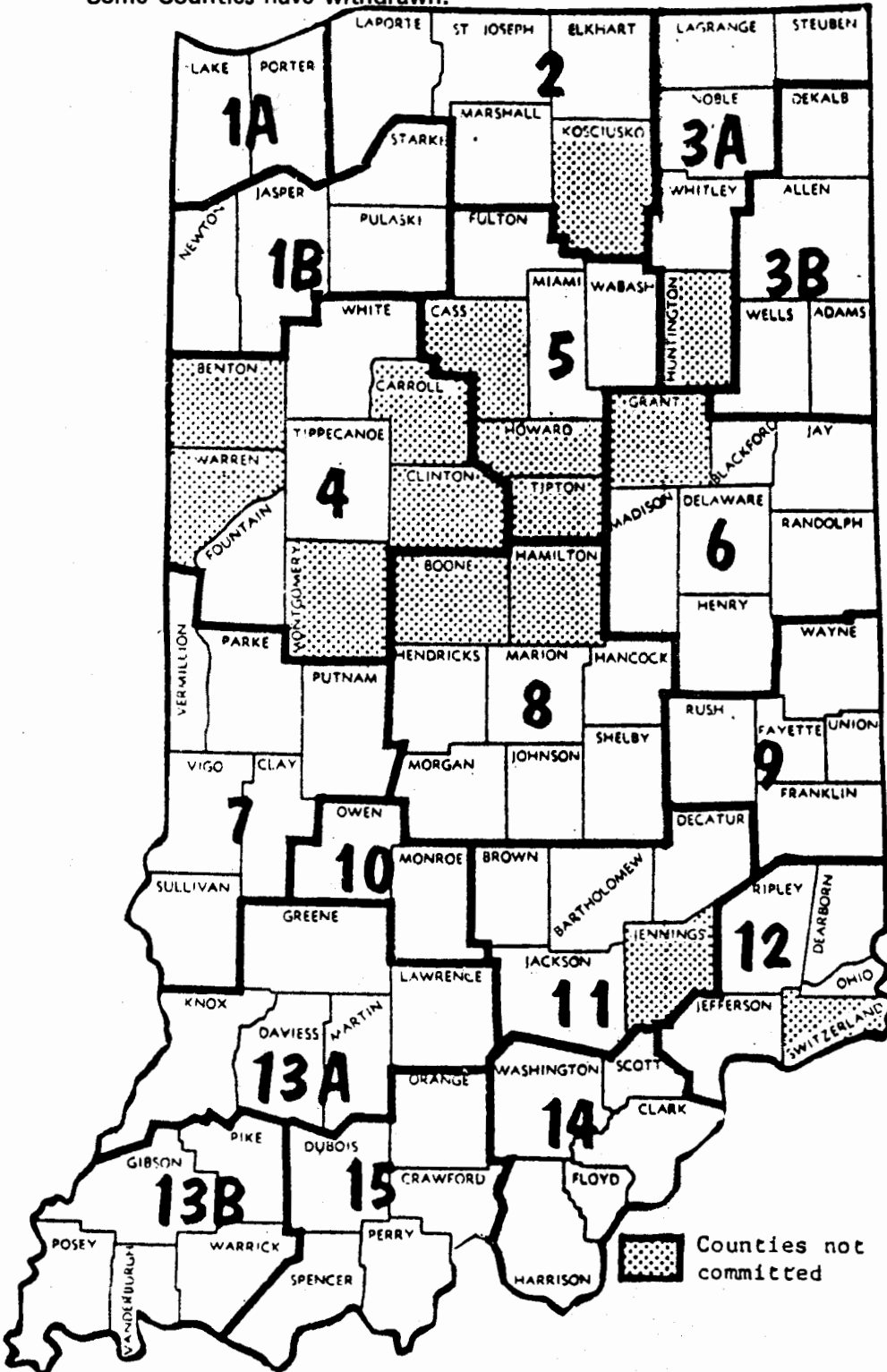

# INDIANA REGIONS

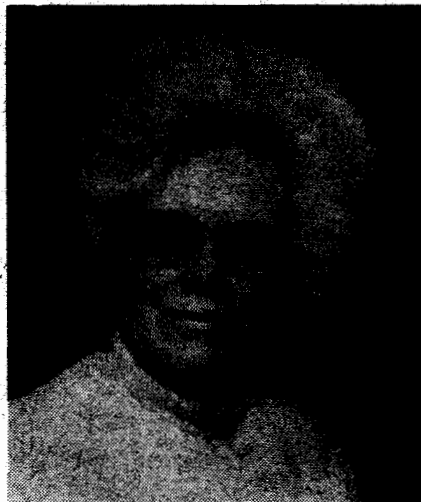
